







### **CLARIFICATIONS**

#### List of queries asked and the answers are given under in italics.

- 1. Is alteration of charges allowed? You may try anything subject to criminal procedure & any applicable law.
- 2. How are the charges supposed to be read, since there is no uniformity with regard to the same? For example: 186, 304 r/w 34 and 186 & 304 r/w 34 are same or is there a difference between the two, as this is not the general pattern followed. *Both are same*.
- 3. Is the charge of abetment on Angad for both the crimes under S. 186 and S. 304? *Check Para 21*
- 4. Will a plan under Section 173 be provided? *Sketch given below (May be treated as Exhibit 3A)*
- 5. Exhibit 3 provides the picture of the Tree and not the Stump. *The protrusion under the tree branches is mentioned as stump.*
- 6. Can a stance of complete denial be taken considering that the facts state that the accused pleaded self defense?
  - You may argue citing anything subject to criminal procedure & any applicable law.
- 7. None of the 161 statements of the prosecution witnesses are given. The statement of the complaint being very crucial. Will that be given to us or we've to prepare without it? *You must argue with whatever information is available in the problem.*
- 8. If the tea stall, auto garage and college gate in the crime scene can be labeled.

  The tea stall (make shift), the auto garage (a small roadside shop for minor repairs etc.) are all functioning under the big tree which is near the bus stop.
  - A representative sketch of the scene of crime is given below **Exhibit 3A**)
- 9. If Dinesh is the same person Tanya complaint about to Abhishek for teasing her. *Para 15 gives the information.*
- 10. The telephonic conversation has been penned down by whom and in what manner. *Presume it is an extract from the appropriate authorities.*
- 11. If the reports not attached are absent or should be assumed to be there.


  You may presume as the situation permits and answer the queries by judges if pointed out.
