 - o Content- Font Size 12
 - o Font- Times New Roman
 - o Line Spacing- 1.5
 - o Citation- Blue Book 19th Ed.
 - o Margins- 2" on each side
- End notes are not allowed.
- Submissions should be made in .doc or .pdf format only
- Co-authorship is permitted up to 2 authors

- No mark of identification should be made at the time of submissions.
