## GENERAL RULES

### 1. VENUE & DATE

The Legal Spectra 2016 will be held from 10th – 13th November, 2016 at S'O'A National Institute of Law (SNIL), Campus-II, Siksha 'O' Anusandhan University, SUM Hospital Road, K-8, Kalinga Nagar, Ghatikia, Bhubaneswar-751003 (Odisha) India. The venue is about 8 km from Biju Pattnaik International Airport and 12 km from the Railway Station.

### 2. ELIGIBILITY & COMPOSITION OF TEAMS

2.1. All Law Schools / Faculty of Law / other Institutions recognized by the Bar Council of India, offering a law degree are eligible to participate in the Competition. Provided, **only one team** comprising of students, pursuing undergraduate LLB degrees (3 years / 5 years) is allowed to participate from each of such Law School / Faculty of Law / other Institutions.

However, in case, a Law School / Faculty of Law / other Institutions offering both 3 years and 5 years undergraduate LLB degrees, two teams, one from 3 years LL.B. course and one from 5 years LL.B. course, may participate.

2.2. A team must be composed of a minimum of 5 members and maximum of 10 members. Provided, any individual participant from a team is allowed to participate in maximum of 5 events, subject to schedule of the conduct of events.

However, the Organizing Committee shall reserve the right to change / alter the schedule of events in exigencies. However any such changes if made, shall be notified to each participating team.

2.3. The team members must be bonafide students of the Institution, they are representing. The Organizing Committee reserves the right to make any inquiries to verify the identity of the participants at any time during the Competition.

2.4. The teams are free to participate in any or all events of Legal Spectra 2015, subject to compulsory participation in any three of the following mentioned events:

MOOT COURT COMPETITION (*Barristers Quill*)

TRIAL ADVOCACY COMPETITION (*Triet Advocacy*)

LEGAL DRAFTING COMPETITION (*Lex Journal*)

PARLIAMENTARY DEBATE COMPETITION

### 3. GENERAL RULES & REGULATIONS

- 3.1. The teams are permitted to participate in the competition on first come- first serve basis. Detailed rules and regulations for each event will be notified in the official website (visit: [www.legalspectra.co.in](http://www.legalspectra.co.in) / [www.snil.ac.in](http://www.snil.ac.in)). Compliance to the rules is mandatory, noncompliance of which may result in disqualification of the whole team.
- 3.2. The proceedings of all the competitions shall be in English. Participants should conduct themselves during the entire proceedings befitting to the students of the institute.
- 3.3. Awards, prizes, and certificates shall be distributed at the Valedictory function on 13th of November 2016 and **under no circumstance the same shall be given or sent to any person via any other medium**. All the participating teams should ensure their presence at Valedictory function.
- 3.4. The Organizing Committee, in its discretion may refrain itself from the conduct of any event and reserves the right to cancel/drop any event, for want of minimum participation.
- 3.5. The Organizing Committee, in its discretion may at any time alter / change any rule (s) whatsoever relating to the Legal Spectra 2016 without prior notice. However, such changes will be duly communicated to the contact person of each team.

### 4. REGISTRATION & REPORTING

- 4.1. All the participating teams of Legal Spectra 2016, should register for the event (s) on or before 31st October 2016. The registration fee shall be of INR 700/- per participant of each participating teams.
- 4.2. The registration fee is required to be paid in the form of demand draft drawn in favour of (**SIKSHA 'O' ANUSANDHAN UNIVERSITY**) payable at Bhubaneswar.
- 4.3. The teams are required to verify their registration via email / phone before their departure for the venue, even though the receipt of earlier confirmation of registration.
- 4.4. A 'Unique Identification Code (UIC)' will be provided to each team via email once the registration is completed as per the procedure. The participating teams shall herein after are prohibited to disclose their or their Institute's identity and they must in all cases be referred by the UIC. Any violation in this regard may amount to disqualification of the entire team and in such circumstances the decision of the Organizing Committee shall be final & binding.
- 4.5. Teams registering Online / Offline must ensure that they have received their 'Unique Identification Code (UIC)' before their arrival at the venue. Teams are also requested to contact the Organizing Committee for non-receipt of UIC within 48 hours of the completion of registration process.

#### 4.5. OFFLINE REGISTRATION

- 4.5.1. A team may register Offline by sending the scanned copy of the duly filled registration form mentioning clearly the names of the events, names of

the participants corresponding to the event, along with the scanned copy of the demand draft and the travel plan via e-mail to [snilevent@soauniversity.ac.in](mailto:snilevent@soauniversity.ac.in) with the subject reading [Registration for the Legal Spectra 2016 — 'college name'], for example —[Registration for the Legal Spectra 2016 - 'SOA National Institute of Law'], on or before 31st October 2016.

4.5.2. The hard copies of the abovementioned documents must be deposited on the arrival of the respective teams on 9th November 2016.

#### **4.6. ONLINE REGISTRATION**

4.6.1. A team may also register Online by filling the online registration form, available at [www.legalspectra.com](http://www.legalspectra.com) on or before 31st October 2016, by 11:59 pm.

4.6.2. Soft Copies of passport size photograph of each participant, Cover Letter by the Head of the Institution (required only in case of online registration), Demand Draft, Travel Plan send via email to [snilevent@soauniversity.ac.in](mailto:snilevent@soauniversity.ac.in) with the subject reading [ Registration for the Legal Spectra 2016 - 'College Name'], for example - [Registration for the Legal Spectra 2016- ' SOA National Institute of Law'] within 24 hours of ONLINE registration, originals of which must be deposited on arrival at the venue on 9th November 2016, failing of which may lead to disqualification.

#### **4.7. REPORTING**

4.7.1. All the registered team shall report positively on 9th November 2016 from 2:00 PM onwards.

4.7.2. All the participants shall carry their college / university identity card at the time of registration.

4.7.5. The Orientation for the participants of Legal Spectra 2016, draw of lots for the preliminary round of Moot Court Competition & Trial Advocacy Competition, along with the exchange of memorial for Moot Court Competition will be held on 9th November 2016 at 7:00 PM, tentatively.

### **6. FOOD & ACCOMMODATION**

6.1. The Host Institute will provide Food and Accommodation from 9th-13th November 2016

6.2. The participants are required to send their travel plan latest by 5th November 2016.

### **7. CLARIFICATIONS**

7.1. Clarifications regarding the general rules and regulations may be sought from the organizing committee via e-mail ([snilevent@soauniversity.ac.in](mailto:snilevent@soauniversity.ac.in)) on or before 5th November 2016.

7.2. In case of general doubts or ambiguities with respect to the rules of any event, (if any), the same will be clarified in the form of corrigenda, which will be sent to all teams via e-mails and via notifications in the official website (visit:[www.legalspectra.co.in/www.snil.ac.in](http://www.legalspectra.co.in/www.snil.ac.in)). The decision of the Organizing Committee shall be final and binding on any matter including circumstances not envisaged in the rules and regulations of the competition.
